

Thurston County Fire Protection District 8 Board of Fire Commissioners' Meeting November 12, 2024

MINUTES of the regular Board meeting held November 12, 2024, at the South Bay Station 8-1 and remotely using Zoom. Commissioners Kilpatrick, Zvirzdys and Bivens, as well as Chief VanCamp, and Secretary Stumpf were in attendance. Commissioners Long, Hunter and BC McBride participated remotely. Several of the B shift crew were all in attendance. The meeting was called to order at 5:30 pm.

<u>Chief's Report</u>: Using a handout, Chief VanCamp presented the October Monthly Report. Questions were asked for clarity, including concerns about the low staffing numbers. The Chief explained that we've had two members on light duty and still have one vacant position.

<u>2025 Master Plan/Proposition 1</u>: Chief VanCamp explained that he is waiting for certification by Thurston county that the excess levy Prop 1 has passed. At present time, it appears to have passed. Once certified, he will present a draft 2025 Budget Plan, then an expense budget will follow; however, we will need to submit resolutions to the county by the end of the month to request revenues for next year. Secretary Stumpf added comments that she'd like to schedule a special Board meeting sometime next week to have the Board review and approve Resolutions. Following a brief discussion, the Board agreed to have a Special Board meeting on Tuesday, November 19th, beginning at 2:00 pm for the purpose of reviewing and approving Resolutions to be submitted to the county. Further, the meeting will be held remotely.

Secretary Report:

<u>Staffing Update</u>- Secretary Stumpf gave the staffing update (*for Assistance Chief LeMay*). She shared that we have seven new volunteer recruits and one lateral that joined us this month. We are still in the process of reviewing candidates' psychological exams for the career position.

Minutes of Previous Meeting – Secretary Stumpf presented the minutes of the regular meeting October 8th for approval. Commissioner Bivens moved to approve the minutes as presented; Commissioner Long seconded the motion. The Board unanimously approved the minutes as presented.

<u>Approval of Warrants</u> - Warrants as audited and certified by the auditing officer, as required by RCW 45.24.080 and those expenses reimbursement claims certified as required by RCW 425.24.090, have been recorded on a listing which has been made available to the Board with the last month's meeting minutes. After extensive review, Commissioner Long moved to approve all warrants as presented. Commissioner Zvirzdys seconded the motion. The Board unanimously approved payment of warrants included in that list and further described as follows:
