engaging in community endeavors such as coaching youth sports and volunteering at local schools and charity events.



June is Pet Preparedness



Include Your Pets in Your Emergency Plan

Make sure your pets are included in your family's emergency plan. Arrange with neighbors, friends, or relatives for pet care or evacuation if you're unable to do so. Microchip your pet and keep information updated. Prepare for your pets as you do for your family by including their

needs in your emergency supply kit. Have two emergency kits: one for sheltering in place and one for evacuation. Include food, water, medicine, ID tags, a carrier, sanitation supplies, a photo of you and your pet, and familiar items.

For large animals, prep beforehand by ensuring identification, planning evacuation routes, and providing necessary transportation and facilities. If evacuation isn't viable, decide on sheltering in a barn or releasing outside.

In case of an emergency, stay informed with wireless alerts and bring pets indoors at the first sign of danger.

The South Bay Fire Department will offer free **Pet Window Stickers** to our community in June. Having a pet sticker on your windows can be helpful for emergency preparedness. It helps alert firefighters about your pets during evacuations, offers clear communication, brings peace of mind, and promotes pet safety in emergencies. Proposition 1 Excess Levy for Maintenance & Operations, August 6th Election

On behalf of the Board of Fire Commissioners and our volunteer and career staff, I want to thank voters again for approving the levy rate restoration ballot measure during the 2023 Primary Election. The added funding provided through the fully restored levy rate (\$1.50) helps us to maintain our service commitments to you.

As we stated in 2023, this was the first of two ballot measures requesting voter approval for fully funding the staffing of our two primary firestations: South Bay and North Olympia. The District has a five-year master plan to provide consistent staffing at both firestations by the year 2027. To fund this staffing, we also need to obtain voter approval in 2024 for a new excess levy for maintenance and operations that will go in effect in 2025.

We strive for consistent, high-quality emergency medical and fire services from our two main fire stations. Challenges include declining volunteers, higher call volumes, and inflation, leading to rising costs. While historically funded by a basic property tax levy of up to \$1.50 per thousand of assessed property value, other fire departments in our area have voter-approved excess levies. Additional funding is needed to uphold staffing and equipment standards and meet service objectives.

On April 19th, the Board of Fire Commissioners approved vancamp@southbayfire.com or call 360-491-5320. placing "Proposition 1" on the August 6th, 2024 Primary Election ballot. If passed, it would increase property tax by \$0.52 per thousand dollars of assessed value for the District.

Emergency medical and fire services impact community safety and homeowner's insurance rates. Levy ballots allow voters to consider these benefits versus costs.
