JOIN US FOR PUSH-IN CEREMONY

We are pleased to invite the community to celebrate the newest addition to our firefighting apparatus fleet with a traditional "push-in" ceremony for our new Pierce, 1,500 gallon-per-minute pumper. The new firetruck, now dubbed "Engine 8-1," officially arrived at the firestation last year.

The dedication ceremony has been a tradition in the fire service that dates back to the late 1800s when fire departments used hand-drawn pumpers and horse-drawn equipment. Since horses could not back apparatus into the firehouse, the crew would have to unhitch the horses then push the apparatus into the firehouse bay.

The ceremony will be held prior to our regular Board of Fire Commissioners' meeting, on Tuesday, April 12th, beginning at 5:30 pm. The event will take place at the South Bay Station located at 3506 Shincke Rd NE. Olympia.

The Department would like to thank the South Bay community for funding this new fire engine. Our new engine replaces a nearly 30-year old fire engine that has served the District well.

2022 goals and objectives

As part of our ongoing comprehensive planning efforts, we have adopted three goals (and their accompanying objectives) for 2022 which include:

- Preparing and implementing an improved staffing deployment model for emergency responders,
- Conducting and completing our collective bargaining agreement negotiations for the 2023-2025 agreement with IAFF Local 2903, and
- Developing and adopting a 2023-2027 financial plan to provide sufficient funding to ensure adequate staffing, operational support and capital assets.

Incident readiness & response staffing

I am pleased to announce that we have employed three new career Firefighter-EMTs that came on board in January. (See front page.) The hiring of these ambitious folks is part of working toward Goal #1 (above) to help us reliably maintain staffing at our South Bay and North Olympia firestations around the clock.

The major challenge has been to recruit and retain volunteer emergency responders due to the impacts of the pandemic, societal changes and other factors. Our average number of volunteer members dropped in 2021 to 42 from a previous average of 61. This decrease has seriously impacted our ability to staff both firestations.

2021 incidents

Last year was very busy for the District, with a total of 1,026 calls. This compares with a fourteen year average call volume of 876 per year. As usual, 78% of the calls were for medical-related causes, both emergency and nonemergency.

An emerging issue has been the delay or lack of availability of private ambulance resources. Typically, the District does not provide ambulance service; however, recently it has been forced to do so many times. This is a result of private ambulance staffing limitations, delays at the hospital for admitting patients and increased call volume. This issue has impacted our staffing availability for the "next call."
